🌟 What's New

Trackers

- Google Health Connect Integration – Users can now sync health and fitness data from supported apps (e.g., steps, heart rate, sleep) directly into Castlight.
- Unified Health Dashboard – View aggregated health metrics from multiple sources in one place.
- Granular Permissions – Users control which apps share data with Castlight via Health Connect.

Challenges

- Launching this June: A standard disclaimer will be added to the onboarding flow.
- It will appear before users visit the Waiting Room page
- The disclaimer will appraise users about the potential of their information being visible to other challenge participants

Year Over Year Comparison of HRA Results:

- Members will be able to compare their current year's HRA report with the previous year if they have completed both assessments.
- The new year-over-year comparison empowers members to track their health progress across 17 key topics, helping them recognize improvements, identify emerging risks early, and stay motivated to take action on their wellbeing journey.

HRA based case automation:

- As part of our ongoing efforts to enhance care coordination, we will be automating the case creation process for members who indicate needs related to safety, social determinants of health (SDOH), or help connecting with a Primary Care Provider (PCP) in the Health Assessment.

- This automation streamlines case creation for safety, SDOH, and PCP support needs, eliminating manual effort and enabling clinical care guides to focus more on member outreach and care—saving time and improving response efficiency.

Redesigned UI -Appointments

- Integrated - Help Me Choose is a service directory that provides a centralized list of all available services on the VERA platform.
 - It guides users to the appropriate appointment types based on their assigned service configurations
 - Update Home Page Appointment Entry Points to Reflect New Scheduling UI- visually engaging card-based design which aligns with Vera's updated scheduling UI.Improved Patient experience and encouraging patient engagement from the home page
 - Auto-Select Visit Type for New vs. Returning Patients -To avoid appointment errors, the system schedules visits based on patient status. New patients can book only new patient visits, while returning patients can book regular office visits.
